## Gold Rush Days Festival Seller Rules and Regulations for the Yard Sale Vendors

1. The Gold Rush Days Festival committee reserves the right to deny any seller application.
2. Seller attests that items for sale are consistent with those one may find at a yard sale, garage sale, estate sale, etc. New or unused items may be sold, but may only represent 15% or less of items offered for sale. If greater than 15% of items are new, please request or download a **vendor** application.
3. Sellers must observe all federal, state and local laws. Items prohibited by law to be sold will not be allowed on premises. In addition, the committee reserves the right to deny the sale of any items deemed inappropriate including but not limited to firearms, alcohol, weaponry, pornography, and items that may cause a public nuisance.
4. Sellers will conduct themselves in a manner consistent with a family oriented event. Loud music, profanity and lewd behavior are prohibited. The Gold Rush Days Festival committee reserves the right to terminate the privileges of any Seller acting in a threatening or inappropriate manner and the Seller will be escorted off premises by security. Seller fee will be forfeited.
5. Tents, tables and any items required for set up are the sole responsibility of Seller. Seller assumes all liability from injury or mishap occurring from the defect or misuse of such items. Sellers must insure that all tables are sturdy and tents properly secured.
6. Seller assumes all responsibility and liability from items publicly sold. The Gold Rush Days Festival committee will not warranty any item sold by the Seller. It will be the Seller's sole responsibility to provide the consumer with information pertaining to warranty or return policy including contact information.
7. Seller location will be determined by and at the discretion of The Gold Rush Days Festival committee. The committee will accommodate special requests for a particular spot if possible, however no reserved spot shall be guaranteed and Seller location is subject to change as necessary.
8. Seller assumes all liability for the safety and security of their property. The Gold Rush Day's Festival committee will not be responsible for any losses due to theft or breakage. Areas left unattended will be at Seller's risk.
9. Festival is rain or shine. Absolutely no refunds except if application is denied.
